Dear Friends,

This year has been a breakthrough year for us at CARADA. We have faced several challenges at the same time worked on new themes and approaches towards our Mission of betterment of marginal communities in the society. We have been able to spread our activities and deepen our interventions in our core objective of transforming small and marginal farmers from subsistence agricultural workers to growing entrepreneurs with ability to optimally use the opportunities in the environment." Several new and innovative models and approaches were undertaken in our interventions. The marginal farmers have significantly improved their collective bargaining power and have been able to improve their production and marketing avenues increasing their overall income. These villages have created a model for other villages surrounding these to follow their paths and eradicate child marriage. The villagers have become aware of the evils of child marriage and taking effective steps to minimize it. The vulnerable children have got foster families and other support systems and are getting groomed in a congenial environment which gives us great pleasure.

We have strived to bring in new dimensions of activities to our 'Maa Gruha'-A shelter for Pregnant women home with a human approach. The Maa Gruha gives special emphasis to Pregnant women both women who are from the economically poor families and do not get adequate support system from their immediate families, neighbours and society at large. We have done some out of the box work like leveraging our targeting groups with Government agencies for support. We have leveraged more fund through various farmer support institutions in our Agriculture and Horticulture Intervention which is a commendable achievement.

In the changing scenario, we are striving for social enterprises in our interventions which will make the organizations sustainable at the same time create livelihood opportunities for the target communities. We are also practicing what we are preaching through our own social enterprise ventures.

I am profoundly grateful to our resource agencies, supporting organizations, partner agencies, fellow development practitioners for their support and cooperation in making our dreams coming true and realizing our goals. A JOURNEY SINCE LAST 30 YEARS:

CARADA started its journey long back with a humble beginning. CARADA is a prominent Pioneer organisation in the Tribal Dominant Kalahandi district in the state of Odisha, India. The presence of natural resources with dense forest has greatly impacted the life of indigenous inhabitants who have lost their livelihoods and assets like lands. Though a small section of people mostly from outside have benefitted immensely due to agriculture output activities, majority of the local indigenous community including significant percentage of tribal people have suffered heavily. The Distress Migration culture in the District has broken the social fabric of their society; they have lost their traditional livelihood through farming and NTFP collection and processing; High pollution has contributed to their health hazards putting them under severe health problems like silicosis, respiratory diseases, TB, skin diseases and other terminal illnesses. In fact even now many affected villages nearer to the abandoned and active mining areas have seen generation of villagers mostly male/female who have been involved in brick making works at Andhra Pradesh regularly suffer from terminal illnesses and lose their life. The agricultural productivity is also impacted negatively due to distress migration.

CARADA is committed to fight for the cause of marginal sections of the society and organised resources for these suffering people so that they can gradually ride the ladder of development and aspire to lead a better life through all round development of Food and nutrition, Best Education, Family security, Livelihood promotion for regular sustainable income sources, best possible use of available resources to generate income. Similarly another area of focus of CARADA is working on Child rights, Health Rights, Reducing MMR and IMR, Stop Early childhood marriage, Reduce vulnerability against trafficking and sexually transmitted diseases etc.

CARADA has manifold intervention areas to reach out to these marginalised sections and bring them up at par with other sections in the society. CARADA collaborates with Government schemes and leverages them extensively so that the huge resource available is accessible to the community people and they can change their fortune. CARADA works as an enabling institution through a well designed process where the people get empowered and take decisions for their own betterment. They are able to scan their environment and use the available supports to the best of the capability so that their income increases manifold and they live a dignified life in the villages with all possible facilities.

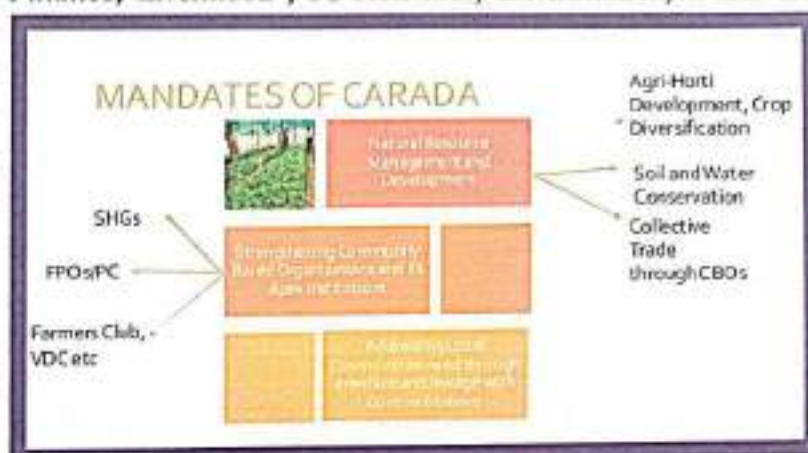

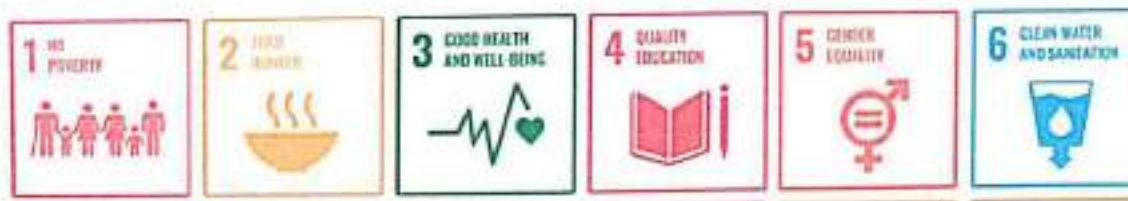

Profile of Our Operational area

The KBK District Kalahandi has consisting of 2 subdivision & 13 blocks. There are 273 Gram panchayat consisting of 2068 revenue villages. It has population of 1335494 out of which Male are 667526 & female are 667968. The rate of literacy is 46.2 % as a whole where as the literacy rate of male is 62.88 % & female literacy is 29.56% as per our record is indicating . The S.C. Population is 236019 & ST. Population is 382573 In the district mainly the education & literacy is very low in the community of the SC & ST.



Operational Area

CARADA is regularly working in Bhawanipatna, Th.Rampur, M.Rampur ,Narla, Kesinga Lanjigarh ,Junagarh, Jaipatna Golamunda & others Block as its operational area and connecting the entire district under the different programme head as per the requirement. Most of the operational area are inaccessible, hilly and forest areas. Economically the habitats are poor & distressed, followed by strong soul's custom & tradition.

Programme Strategy

We always believe on the community as the key stake holder, who will create a change in the society. When community ownership will develop & a self confident mindset will increase, then only. We can bring back a remarkable change in these areas, The system & political policies has change the mind set & prepared the community towards govt. depending in these areas, so approach of ownership with demonstration programme can only open up the eye & vision, Therefore any programme we have undertaken are comparing from the core of the community as per the need base and apprise.



3. ACTIVITIES DETAILS

During the year 2022-23 CARADA Conducted following key activities in Kalahandi district of Odisha with the support of different Agency ,Individuals , State & Center Govt and others agency .

3.1. MANAGEMENT OF HEALTH & WELLNESS CENTER & PHC NEW

3.1.1.Public Health System

The public health system is run by the National Health Mission of Odisha. At the district level, Kalahandi has a District Health Mission that works under National Health Mission Odisha. The district has its own government public health infrastructure. It has 1 district hospital, 1 sub-divisional hospital, 10 community health centers, 8 health and wellness centers, 20 public health centers, 234 sub centers, and 26 public health centers. As a part of the implementation of the National Health Policy, the strengthening of sub centers and public health centers is being done by converting them into health and wellness centers to deliver equitable, accessible, comprehensive primary health care service.

3.1.2.Current Situation:

The maternal mortality rate is 126, infant mortality rate is 32, sex ratio is 1011 female per 1000 male and child sex ratio is 898 female children per 1000 male children. Despite the area's abundant natural resources, the majority of its residents lack access to basic survival necessities. Though Odisha has shown an impressive increase in health indicators as per the National Family Health Survey 5, survival indicators for both children and mothers in a district like Kalahandi are still poor as compared to other parts of the state. Even for children who are introduced to their first doses of immunization, there is a significant drop in children coming for subsequent immunization sessions. Similarly, while Odisha's institutional delivery has risen to 85.4%, it stands at 74.5% in Kalahandi. The district still has 25.5% of home deliveries, with only 6.4% of the total home deliveries assisted by trained and skilled birth attendants. Only 46.7% of mothers in Kalahandi receive full Antenatal Care (ANC) service, with only 58.8% receiving Postnatal Care (PNC) within 48 hours of delivery. These practices have a high impact on the survival of children, especially neonates. It is also experienced that the impact of development has not been uniform in all communities, and tribal communities stand at a special disadvantage when it comes to receiving and accessing health services. In terms of general health, there is a high incidence of tropical diseases like malaria and diarrhea. This is especially acute in remote areas where access to quality healthcare is inadequate. The level of malnutrition in the area is also high, which increases the need for a quality primary healthcare system and community health-seeking behaviour in Kalahandi.

3.1.3.Challenges:

The health system in Kalahandi district has many challenges. The district has still not recovered from the COVID pandemic crisis that caused the entire health care system to collapse. It has also had a significant economic impact on people's income generation. Disparities between urban and rural areas, as well as between rich and poor, are having an increasing impact on society. There is sound evidence that shows poor economic conditions and poor infrastructure cause poor health. The scarcity of skilled human resources makes it even worse for the health care system. Communicable diseases such as tuberculosis, malaria, tropical diseases, dengue fever, and HIV coexist with noncommunicable diseases such as cardiovascular disease and chronic diseases caused by tobacco and alcohol. The district is located in deep forest and mountains. Environmental causes like drought, irregular rainfall, excessive mining, unplanned



and unregulated development and unregulated land use all contribute to risk factors in public health care accessibility and developing infrastructure.

Kalahandi has a large number of tribal populations, which suffer from various health crises such as communicable and non-communicable diseases, malnutrition, addiction and mental health issues. The people from the district are not very well integrated in socio-economic development, as it is socially and geographically isolated. It leads them to poverty, poor health and poor literacy. The patriarchal system creates barriers to getting or accessing health care for women and girls in cultural challenges. The silence surrounding sexually transmitted diseases, child marriage and mental illness has serious consequences for people's health.

3.1.4. Activities to Address the issues

CARADA has been Operating Health & Wellness Center, Primary Health Center (n) at Artal of Bhawanipatna Block of Kalahandi district on PPP Mode under NHM . It has covered 34 village under 7 GP of Bhawanipatna Block .In the dispensaries Doctor , Pharmasist and others staffs of the PHC has been regulary checkuped and treatment to Children , Adolescent ,ANC,PNC ,Pregnant Women of the project areas in free service.

During the last 3 years the PHC New was selected for Kayakalpa award by CDM & PHO Kalahandi .

The Primary Health Center will be the basic unit of service delivery .The details of services and programme delivered as follows .

- III. Care in pregnancy and child-birth
- IV. Neonatal and infant health care services including Immunization'
- V. Childhood & adolescent health care services inciuding immunization.

- VII. Management of Common Communicable Disease sand General Outpatient care for acute simple illnesses and minor ailments'
- VIII. Flanagement of Communicable diseases' Screening and Management of Non-Communicable diseases including Promotion of healthY life style.

- X. Care for Common Opthalamic anad ENT ptoblems'
- XI. Basic Dental health care.
- XII. Geriatric and palliative health care services'
- XIII. frauma Care and Emergency Medical sen'ices'

4. MANAGEMENT OF MATERNITY WAITING HOME(MA GHRUHA)FOR MATERNAL HEALTH SERVICE & INSTITUTIONAL DELIVARIES

In Kalahandi District ,CARADA has been Implementing two nos of MA GHRUHA (Maternity Waiting Home) Project at Chapuria of Golamunda Block and Saisurni of Th.Rampur Block of Kalahandi district. The project is supported by National Health Mission Odisha ,Kalahandi on PPP Mode. It is a temporary home for expectant mothers where they can wait for delivery. On onset of labor, they are to be shifted to nearby health facility having BeMOC facilities for delivery.





4.1.Objectives:

- A. To establish alternative support infrastructure for address in communication Problems in difficult tribal pockets for ensuring institutional delivery.
- B. To increase institutional delivery in the difficult tribal pockets.

4.2.Salient Feature:

- A. Accommodation facilities for expectant mothers & her escorts*.
- B. Provision of food for expectant mothers, dependants & escorts.
- C. Lady Health Care Assistant for attending cases in shifts.



- D. Provision for shifting of cases from Maternity Waiting Home to hospital.
- E. Regular health check-up by doctor.
- F. Health education sessions through IPC & Audiovisual aids.
- G. Compensation for Loss of wages to expectant mother.
- H. Recreation facilities at Maternity Waiting Home.
- I. Client friendly environment & support

7. MOBILISATION ON SPECIAL MGNREGS PROJECT TO ARREST DISTRESS MIGRATION IN MIGRATION PRONE BLOCK OF BHAWANIPATNA BLOCK.

CARADA was implemented Special MGNREGS Project to Arrest Distress Migration in Migration prone Block –Bhawanipatna under DRDA Kalahandi since 2019-20 and during the year ,it has been mobilized to migrated labours for wage employment and self employment in 12 Migration affected G.P of Bhawanipatna Block of Kalahandi & the G.P were :-Artal, Borbhata, Dadpur, Deypur, Dumuria, Gudialipadar, Kendupati, Medinpur, Palana, Seinpur, Sripur, Udepur for involved in MGNREGA programmes implemented in different Blocks. hawanipatna Block to check distress migrant under a pilot project of government. The main objectives of this programme to ensure all days wage employment guarantee to each household in a financial year to develop sustainable livelihood security plan to each household in Gram Panchayat level with creation of household and community level assets.

8. MANAGEMENT OF BIKE AMBULANCE IN REMOTE AREAS

CARADA has been managed on Bike Ambulance project in hard to reach village of Saisurni sector under Th.rampur Block under the support of NHM Kalahandi and District Administration Kalahandi to ensure the survival of mothers and children in Kalahandi district, it was decided to implement the motorcycle ambulance as pilot. This will be achieved by both adapt/ upgrading in communication system in hard to reach areas. It will maximize access to the health facility .

Objectives .-
